Eligibility Requirements**

- Dream Grant will be awarded up to \$10,000.
- The Dream Grant will provide financial support to assist with costs associated with fertility treatment or

adoption. Request for fertility or adoption assistance must be specified in the grant application.

- Grant money is dispensed directly to the service provider (fertility clinic, or adoption agency) not to the family applying for the grant.
- Support is considered only for couples who are legal permanent U.S. residents, residing in the United States (citizens or green card holders) with documented infertility.
- The Dream Grant winner(s) will be announced at the Sweet Dreams Gala and Resource Fair. Applicants must be present in order to win.
